**Findings and Recommendations of the Committee:**

1. Upon thorough examination of the proposal, it is found that only two bidders successfully qualified for the financial evaluation, The qualified bidders are M/s Kanhei Charan Das & M/s Rakesh Sharma.
2. Additionally, the committee suggests promoting broader participation, expanding the scope, fostering increased competition, ensuring transparency, refining the evaluation process, and implementing efficient record-keeping. As a result, the committee proposes canceling the existing tender and initiating a new e-tendering process.
